Madam/Sir.

I am directed to refer the Govt. of Gujarat letter No. FCA-1021/10-09/21/S.F-232/F dated 22.03.2022 forwarding reply of this office letter dated 27.01.2022 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980. The detailed examination of the proposal has revealed that:

- i. More clarification is necessary with respect to the technical aspects deliberated by the User Agency in the explanation provided for not examining the possible alternative alignment before finilising the present alignment.
- ii. The User Agency has mentioned that there is proposed canal based small hydro-power plant at this location. It is not clear whether the hydro power plant will be commissioned as part of the project or will it be commissioned as a separate project in the same location in due course of time.
- iii. It has to be made clear whether the proposal involve provision for installation of canal based small hydro power plant as part of the project. Thus before issuing Stage-I, the concerned officials from the user agency are requested to make a presentation and provide proper explanation to the points mentioned above.

Accordingly, you are requested to inform User Agency to intimate User Agency to 2. make presentation about the proposal on above issues during the next FRCM for which information will be sent in advance.
