- Sub: Proposal for diversion of 6.005 ha forest land for construction of Denzi Small Hydro Electric Project (10 MW) by M/s Buru Enterprises in West Kameng District of Arunachal Pradesh.

Sir,

Please refer to the State Govt letter on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980, I am directed to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and following lacking information/documents has been observed: -

(i)The corrected component wise break up of the area is to be submitted as the break up mentioned in Part I form is different from the submitted layout map.

(ii)The location and number of Hydro Electric Project located in the upstream and downstream on river Nangrum River along with its distance to be shown in the scale map 1:5000.

(iii)Whether the road to the proposed HEP site is a new road or road already existing.

(iv)The certificate for land availability certificate from Deputy Commissioner, West Kameng District, Bomdilla and NOC from the Water Resources Department, Department of Fisheries of the proposed HEP as the submitted certificates is for 18 MW Denzi Hydro Electric Project and not for 10 MW.

(v)The aerial distance of the proposed area from the nearest Protected Area/National Park/Wildlife Sanctuary as it is mentioned as 73 km from Eagle Nest Wildlife Sanctuary in Part II form whereas 15.42 km (approx.) in the submitted layout map.

(vi)The corrected enumeration list of the trees to be felled as it is mentioned as 161 Nos. (25 Nos of trees and 91 Nos. of poles) whereas uploaded as 29 nos. of trees.

(vii)The GPS coordinates of the proposed component wise break up of the proposed area.

(viii)The requirement of material for construction of dam etc. and its source has not been mentioned in the proposal.

(ix)The muck disposal plan mentioning quantity of the muck to be generated and dumped with GPS coordinates approved by the concerned DFO.

(x) The current status of the F(R) Act, 1980 of this instant proposal.

(xi)The approved CAT plan by the PCCF, Govt. of Arunachal Pradesh.

(xii)The GPS coordinates of each components breakup involved in this proposed HEP.

(xiii) The breakup area of FRL's involved indicating nos. of trees to be affected.

(xiv) Study for Cummulative Impact Assessment & Carrying Capacity Study (CIA & CCS)

for this proposal of Denzi small Hydro Electric Project (10 MW), if any .

(xv) The kml/shape file of the identified CA area not uploaded on portal.

(xvi) The status of the Environmental clearance, if applicable.

State Govt. is requested to furnish the above information to this office at the earliest for further processing of the proposal.
