सन्दर्भ: i). अतिरिक्त मुख्य सचिव (वन एवं वन्यप्राणी), पंजाब सरकार Forest-FCAOFC3P/64/2022-FCA दिनांक 10.03.2023.

महोदय,

उपर्युक्त विषय से सम्बंधित संदर्भांकित पत्र, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा-2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.858 हेक्टेयर वन भूमि की मांग की गई है।

2. प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे: -

- i) In part-I -A-2, Name of UA is uploaded 'Dibyendu Dass' instead of Road & Bridges Organisation of Indian Army, needs to be corrected online.
- ii) Justification & detailed note of the project does not contain the brief information regarding necessity of the instant project, In Justification, UA states that proposed road is required due to heavy traffic intensity, from the project site KML analysis through DSS, it's appeared that instant proposed roads does not have heavy traffic intensity, detailed report regarding necessity of project needs to be uploaded.
- iii) Temporary employment is uploaded as 0, needs to upload realistic figures in-terms of no. of person-days & permanent employment is uploaded as 20 instead of Nil, needs to be corrected online.
- iv) In part-II, 4(ii) 6 no. of felling trees out of 11 trees uploaded as misc species, needs to upload their local name & scientific name as given in marking list.
- v) In layout plan, proposed area to be widened is shown as 2 mtr(b/s) & the existing road width is given as 3 m, whereas the calculation is done from 7 mtr. instead of 4mtr. In addition, 60m*1.5m additional patch from above also proposed in layout plan, weather the justification of patch, necessity is not described.
- vi) Approval for the project has been accorded for provision of internal roads connecting Mamun Military Station to Ajeya Garrison (Phase-II), whereas the instant project is widening of road from Karoli to Bana Enclave, which needs clarifications.
- vii) NOC from the land owing agencies as area under reference is covered under PLPA-1900.
