## Sub: Diversion of 0.105 ha of Reserved Forest land in favour of Daund Municipal Council, Daund for replacing underground water pipeline at Village- Mergalwadi, Taluka- Daund, District-Pune in the State of Maharashtra- regarding.

The undersigned is directed to refer to APCCF & Nodal Officer (FCA), Maharashtra letter no. Desk-17/Nodal/Pune/I.D-13100 (23)/2598/2021-22 dated 03.03.2022 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and to say that preliminary scrutiny of the proposal in the Integrated Regional Office, MoEF&CC revealed following:

- i. User Agency has mentioned that most of the part of existing pipeline passes through the land falling within RoW of Baramati-Daund Road. Further, examination of KML of proposed area, revealed that the road is passing through Reserve Forest. In this regard, copy of letter in the form of approval obtained for construction of Baramati-Daund Road from the Central Government may be submitted.
- ii. Date of submission is not mentioned in Part- III. Revised copy of Part- III mentioning date of submission and name of signing authority shall be submitted.
- iii. Certificate related to recognition and vesting of forest rights in accordance with the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 is not submitted along with the proposal. Original FRA- 2006 certificate along with documentary evidences in the form of copies of the resolutions of the concerned Forest Rights Committee(s), Gram Sabha(s), Sub-Division Level Committee(s) recording their consent for the proposal and bearing signature of the participants shall be submitted along with English translated copies.

In view of the above, I am directed to request the State Government to submit information on the shortcomings, as indicated above, to this Ministry for further consideration of the proposal for approval under the Forest (Conservation) Act, 1980.
