Diversion of forest area for formation of roads in LWE districts —request to identify suitable non forest area for compensatory afforestation purpose -reg.

Sir.

With reference to the subject, it is to inform that the Andhra Pradesh State Government recently forwarded certain road proposals (Annexure-I) falling in Left Wing Extremism (LWE) Districts to IRO, Vijayawada seeking approval under FCA, 1980.

On scrutiny of these proposals, it is noted that provisions for Compensatory Afforestation as per the guidelines in vogue has not been made in the said proposals. In this connection, it may be noted that para 4.4 of the Comprehensive guidelines related to General approval for public infrastructure projects in LWE District has expired on 31.12.2020 and therefore, exemption of provision of CA for such projects is not applicable presently.

In view of the above, it is to requested that suitable non forest area for compensatory afforestation may be identified and the details of the same may be submitted including map, DGPS co-ordinates, KML file, CA scheme, site suitability certificate etc. for further consideration of the proposals. These details shall also be uploaded in the online application.

Since these LWE districts proposals are being reviewed by the Ministry regularly, timely action under FCA, 1980 needs to be taken on these proposals. Hence, it is requested to submit above information at the earliest please.
