In inviting a reference to the correspondence cited above on the captioned subject, wherein you were requested to furnish the compliance on point No. (b) as sought for by Dy. Inspector General of Forests(C) Government of India, MoEF & CC, Regional Office, Bhubaneswar vide its letter No. 5-ORB614/2022-BHU dt. 24.11.2023 for diversion of 1.216 Ha. (3.005 Ac.) of Forest Land in favour of M/s Mayfair Hotels & Resorts Ltd. under Bhubaneswar Tahasil of Khordha District under Chandaka Wildlife Division. As per DSS, an area of approx.1070 sq. meter of the CA area is falling in water body and two metalled roads are passing through the identified CA area. This may be clarified by you in view of the suitability of CA land and encroachment free land. But, your report in this regard has not been received in this office till date.

Therefore, you are once again requested to furnish the compliance report in consultation with the concerned authorities to this office for onward transmission to higher quarters at the earliest.
