

- After careful examination of the above-mentioned proposal of the Government of J&K the following information/clarifications are still required to be submitted:
 - In the component wise breakup of the forest land the extent of forest has been (i) mentioned 2.675 ha which does not match with the area proposed for diversion. Need to be corrected and submitted.
 - Undertaking to pay Addl. NPV to be submitted. (ii)
 - CA estimate is not clear whether it fulfills the elements of CA given under Para (iii) 2.8 of FCA 1980 guidelines. Need to be corrected and submitted.
 - Detailed muck disposal plan to be submitted. (iv)
 - DSS/goggle earth shows that CA site is 6 ha out of which 5.75 ha vacant space (v) is available and 0.25 ha of additional vacant space is required.
- The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.


