

Subject: Diversion of 3.2193 Ha. of forest land in favour of HPPWD for the construction of Munder Kungal krog Khori Gadasu road (Km 0/00 to 9/730), within the jurisdiction of Rampur Forest Division, Distt. Shimla.

Memo: Please refer to online EDS dated 04-02-2022 on the subject cited above.

2. The following shortcomings have been noticed which may be attended in all respect:-
 1. As per KML file there are 6 villages to be benefited have been marked whereas, in village wise breakup only 5 villages have been mentioned.
 2. The FRA certificate issued by DC as uploaded against the column No. K of Part-II without signature, hence revised certificate may be uploaded.
 3. The cost of project as mentioned in online Part-I is mentioned 930 lac. whereas 9.30 lacs has been mentioned in the Part-I as uploaded against Sr. No. 2 of additional information detail, correct figures may be given.
 4. Executive Engineer has not signed the layout plan of the proposed road as uploaded against Sr. No. 2 of additional information detail Part-I, correct figures may be given.
 5. The abstract of enumerated trees as uploaded against Sr. No. 2 of additional information detail of Part-I, is not signed by DFO concerned.
 6. The Penal CA has been proposed in lieu of the forest land already broken whereas Penal NPV bill is not required to be prepared.
 7. As per the check list No. 7 of the proposal, UPF (un-demarcated Protected Forests) & DPF (Demarcated Protected Forests) has been mentioned whereas, as per column No. 2 of online Part-II Protected Forest & un-protected Forests has been mentioned. Necessary clarification/ correction in this regard be done.
 8. From the perusal of the KML file of CA site it seems that there are already trees on the site, hence the CA site may be reviewed or it must be mentioned in the CA land suitability certificate that proposed CA area is having less than 40% canopy density.

It has been noticed that, while submitting the reply of the observations, the reference of uploaded document (i.e. Sr. No., column No. & Part) are not being mentioned in forwarding memorandum, due to this it is difficult to find/scrutinize the concerned document, hence, complete detail of uploaded documents be given in the forwarding memorandum.
