Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **1.905** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Government of J&K the following information/clarifications are still required to be submitted:

- (i) Total period for which forest land is required is shown as 150 instead of 99 years.
- (ii) Village wise break-up of forest land in part-I is shown as NIL.
- (iii) Permanent/ Regular employment is shown as 338 person. Need to clarify.
- (iv) Proper lay-out of the project.
- (v) Site specific CA site as per provision contained under Para 2.8 of FCA guidelines.
- (vi) Action taken report against the person responsible for violation from the DFO.
- (vii) Calculation of Penal NPV is seemingly incorrect. The figures may be rechecked and verified for accuracy as per the provision under Para 1.21 (ii) (a)
- (viii) Site suitability certificate of CA site has not been submitted. It has been seen in the DSS that the site is rocky/tough terrain. DFO to confirm suitability.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
