- DSS/goggle earth shows that the KML file of proposed project site is shown 4.87 ha instead of 8.525 ha. Rectified KML and DGPS map to be submitted.
- CA has been proposed over only 9.25 ha of DFL instead of 17.05 ha. Out of which 7.43 ha of vacant space is available. Balance CA area of 9.32 ha to be submitted. If required changes to be made in the site specific CA estimate.
- Correct letter of authority bearing seal and signature of the superior authority of the applicant to be furnished authorizing the applicant to file the proposal.
- Comprehensive muck disposal plan to be submitted.
- Complete administrative approval letter with bearing name and number of the concerned proposal to be submitted.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
