Subject: Diversion of 21.6 ha protected forest land with felling of 1,554 numbers of trees for widening and strengthening of Chibramau-Sorikh-Bidhuna Road (MDR 13) from km 0.000 to km 31.000 in Kannauj District, UP-reg.

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. The kml file of diverted forest land has not been provided in CD. The uploaded kml file shows a shift and does not exactly show the proposed forest land. The same needs revision.
2. The geo referenced map uploaded for proposed forest land diversion lacks geo coordinates of all key points.
3. The uploaded topo sheets showing proposed forest land diversion is incomplete and proposed forest land is shown on beyond the boundaries of topo sheet.
4. Land schedule uploaded as additional document of part I is without details of balance RoW or forestland after accounting proposed forest land diversion.
5. The proposal is without enumeration of pole size crop.
6. The Compensatory Afforestation (CA) estimates uploaded and CA estimate provided in hard copy are at variance. The uploaded CA estimate includes abstract of plantation on vacant space and on divider also.
7. These two additional Compensatory Afforestation (CA) estimates are without due vetting from the State Government.
8. The hard copy of proposal does not contain filled up part V (recommendation of the State Government).
9. The recommendation of DFO for the proposal has not been uploaded at Sr No. 16 of the part II.
10. The benefit cost analysis enclosed with the proposal is not as per FCA guidelines and needs revision.
