Sub: Diversion of 1.35 ha of Forest land for upgradation and maintenance of road from L041-Zaloor to Gujjerpathi, District Baramula-reg.

Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 1.35 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Government of J&K the following information/clarifications are still required to be submitted:

- (i) Total period for which forest land is required is shown as 150 instead of 99 years. **UA**
- (ii) Site specific CA scheme has not been given. **UA**
- (iii) Undertaking to pay Addl.NPV is not given. **UA**
- (iv) Permanent/ Regular employment is shown as 395 person. Need to clarify. **UA**
- (v) DGPS map of project site with proper geo-coordinates to be submitted instead of Google Earth Screenshot. **UA. DFO**
- (vi) DGPS map of CA site with proper geo-coordinates to be submitted. **UA. DFO**
- (vii) Incomplete KML of proposal has been submitted without adding the forest portion. KML of both forest and non-forest portions to be submitted. **UA**
- (viii) As per analysis of CA site on DSS, additional 0.60 ha of vacant space required to meet target plantation. **DFO**

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
