- 4- Certificate from DFO that the Compensatory Afforestation has been examined through Decision Support System(DSS) by him alongwith result of the same in the CA Scheme as per the proforma given by the PCCF, Odisha vide his memo no.21393, dt.13.12.2021 is wanting.
