Kindly refer to the Government of West Bengal's letter No.163-For/O/L/10T-02/2022 dated 11.02.2022 on the above-mentioned subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980. The proposal has been examined by this office in accordance with Forest (Conservation) Act, 1980, and the following information are required for further processing of the project.

1. The proposal not being site specific, 3 alternate sites must be provided with justification and details of selecting these sites needs to be submitted by the UA.
2. Part-I signed with name, designation and date needs to be uploaded on PARIVESH.
3. Minutes of meeting of Gram Sabha, District Committee and State level regarding FRA needs to be submitted.
4. Legible copy of SoI Toposheet (1: 50,000 Scale) showing proposed forest land for diversion and proposed CA needs to be submitted.
5. Number of plants proposed for plantation per hectare needs to be provided.
6. In the lay out map of Proposed project UA submitted that residential accommodation / Quarter will be constructed. Details regarding the numbers needs to be submitted.

7. In Part (II) pt. 4 Density of vegetation is given as 25.28. it needs to be clarified.

In this regard, I am directed to request you to submit and upload the above information in the PARIVESH portal for further consideration.
