भारत सरकार के उपरोक्त संदर्भित पत्र (छायाप्रति संलग्न) का अवलोकन करें। विषयांकित प्रकरण मे भारत सरकार द्वारा संदर्भित पत्र से अतिरिक्त निम्न बिन्दुओं की जानकारी चाही गई है :-

- 1. The State Govt. has now revised the KML file of the instant project and the canal proposed and passing through the Non-forest land have been included in the KML file. However, it is imperative to mention here that the canal area which has been proposed to be constructed in the Non-forest land has not been included in the component wise details furnished in the Part-I form. The State shall ensure that the component wise details of forest/non-forest land involved are correctly mentioned in the online application form.
- 2. The State government was asked that the suitability of the area for compensatory afforestation is required to be examined again. In this regard, the state has informed that the area earlier proposed for CA (on NFL) has now been changed and the same is suitable. However, the state has at the same time proposed certain area on DFL for plantation of additionalseedlings. In this regard the State shall ensure that the area (NFL) proposed for CA is suitable for raising Compensatory Afforestation as per the provisions of Van (Sanrakshan Evam Samvardhan) Rules, 1980.
- 3. The State Govt. has not informed as to how much area of the proposed NFL is not suitable/fit for raising compensatory afforestation of a specified density and the reasons for the same have also not been specified.
- 4. Analysis of the satellite imagery of degraded forest land proposed for plantation has revealed the presence of plantation work in one patch namely PF 936 and a part of proposed patch namely RF-478 is affected with encroachment/ Agriculture.
- 5. As asked in the previous communication, the State Government has not verified the total numbers of the trees getting affected.
