With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. On scrutiny of the proposal, the following has been observed.

1) The DFO, Boudh has reported that no violation has been committed by the user agency under FC Act, 1980. However, as per DSS report, one tower has been erected over forest land in violation of FC Act, 1980. Detail extent of forest land used and action taken report by Revenue authority against the erring Revenue officials and the user agency responsible for causing diversion of forest land may be furnished.

It is therefore requested to furnish the above information to this office for further processing of the proposal.
