Sub: Diversion of 44.16 ha of forest land for widening and strengthening project of Sonepur - Darihara Road (0.00 - 39.40 Km) in Saran district of Bihar.

Sir,

I am directed to refer to your letter No.Van Bhumi-01/2018-398(E)/Pa.Va. dated 3.4.2018 on the above mentioned subject and to inform that the proposal has been scrutinized and it is observed that following major documents/ information are still required in the proposal:

- i. As per details of the area calculation, forest land required is 33.49 ha. But total 44.16 ha forest land is proposed for diversion. It may be clarified.
- ii. As observed on our Decision Support System, total CA land calculated from the submitted kml file is 71 ha. However, 90 ha Degraded Forest Land is proposed for CA. However, a correct geo-referenced map for the proposed CA land should be submitted
- iii. Some minor observations are as follows:
 - a. Two separate Part-I is submitted by the user agency for Km 0.00 to 21.00 & Km 22.00 to 39.40. A consolidated Part-I in original with mentioning name & address of the applying authority should be submitted by the user agency.
 - b. Part-II for 24.15 ha forest land from 0.00 to 21.00 Km is submitted. A consolidated Part-II in original with mentioning the name of the signing authority for 44.16 ha should be submitted in this office.
 - c. Part-III for 24.15 ha forest land from 0.00 to 21.00 Km is submitted. A consolidated Part-III in original with mentioning the name of the signing authority for 44.16 ha should be submitted in this office.
 - d. Cost Benefit Analysis for 44.16 ha as per Ministry's guideline No.7-69/2011-FC(pt) dated 1.8.2017 may be submitted in this office.

It is requested that the above mentioned documents/ information may kindly be provided to this office for further processing of the proposal.
