With reference to the above mention subject and letter under reference, undersigned is directed to inform you that proposal needs further clarification. In this connection, I am directed to request you to submit following information/ documents:

- Part-III of proposal is not submitted and uploaded on web portal.
- The proposed diversion area is 6.98 km away from Satpura-Melghat tiger corridor. 2. Comments of CWLW, Madhya Pradesh shall be submitted.
- Suitability certificate of CA land shall be submitted. 3.
- The CA scheme as per Para 2.8(iii) shall be submitted. 4.
- It is not clear from the proposal that what is before and what is after proposed alignment. 5.
- No objection certificates of concerned departments (Irrigation, railway etc) need to be 6. submitted.
- Component wise breakup of land required and component wise area calculation with the 7. layout plan needs to be submitted.
- Detailed muck calculation and muck disposal scheme as approved by concerned DFO needs 8. to be submitted.
- Administrative approval/sanction letter of the project shall be submitted. 9.
- Area calculation sheet needs to be provided. 10.
- Plantation scheme for roadside plantation needs to be submitted. 11.
- When was the existing road constructed ? If after 1980 and permission is not taken under 12. FCA, then the proposal should include the area of existing road as well.

Further, necessary action will be carried out after receipt of above information.
