Sub:- Reg. undue delay in processing of proposal no. FP/UP/Trans/144301/2021.

Mam,

This is to bring to your kind notice that above proposal was received in this office on 13.05.2022, after processing of the proposals certain information was sought by this office vide letter dated 14.06.2022, the compliance of this letter was received from the nodal office vide letter dated 07.09.2022. Since the reply was incomplete/ambiguous, so again a letter for clarification of same was sent on 30.09.2022. The reply of this was received from the Stage Govt./Nodal Officer on 21.11.2022 which was again incomplete/ambiguous. Subsequently due to continuous inadvertent reply of state govt. again and again EDS was sent and now again the proposal needs certain clarification. Such laxity on part of DFO causes an undue delay in the execution of such important govt. projects.

It is, therefore, requested to kindly direct the concerned to send the complete compliance on following points and also initiate suitable action against the concerned DFO for causing such inordinate delay in the execution of Govt. projects.

1. It has been replied that the area proposed for CA is a failure plantation however no cogent reason has been put forth for failure of plantation and also no details have been furnished w.r.t. the process by which the plantation has been declared failure.
