: Diversion of 5.70 ha of Protected Forest land for the construction of cement concrete road with beautification work Surat branch canal road on both side of exixting canal from Anuvrat Dwar Junction to Jamnaba Park via G.D. Goenka School (0//0 to 3/0) in favour of Executive Engineer, Road Development Department, Surat Municipal Corporation in Surat District of Gujarat-reg.

Kind reference to above subject, the proposal was examined ate RO, Bhopal and I am directed to request you to submit following documents / information in connection to be observations of this office:

- 1. The KNL file of the proposed diversion on both side of road in polygon format of area 5.70 ha shall be uploaded on e.portal.
- 2. The CA land was examined on DSS and out of 12 ha proposed for CA, 8.00 ha is MDF.
 - a. Revised CA land required project in open forest having C.D. less than 0.4 shall be submitted and uploaded on portal along with all required documents for required like site suitability, site inspection, geo-ref and top-sheet maps, etc.
- 3. The site specific CA for revised CA land shall be submitted and uploaded. The specific CA scheme needs to be prepared as per the Para 2.8 (iii) of FCA Handbook 2019 and include the following points:
 - i. Standard size 1000 Saplings per Ha to be planted (Minimum standard height and minimum collar girth species wise) as approved by the State Govt.
 - ii. Soil & moisture conservation works.
 - iii. Regeneration cleaning.
 - iv. Silvicultural and other activities as prescribed in the working plan including dressing of all coppicing species stumps upto 90 cm from the ground level.
 - v. Species to be planted (species wise number of plants).
 - vi. Details of proposed monitoring mechanism and outcome parameters.
 - vii. Technical and administrative approvals of the current year from the Competent Authority.
 - viii. The CA scheme shall have 10 year maintenance excluding the plantation year.
 - ix. Recording of survival %, height and collar girth species wise at the time of plantation, once every year and at the end of maintenance year.
 - x. Recording of stump dressing girth wise and species wise.
 - xi. The revised site specific CA scheme shall be uploaded on e.portal
