With reference to the above mentioned subject and letter under reference, I am directed to inform you that after examination it is observed that this proposal have some shortcomings. Further, I am directed to request you to submit the following documents/information:

- 1. Alternative examined for the proposed pipeline along with comparative statement shall be submitted.
- 2. Sol toposheet map and geo-referenced map of proposed diversion land and CA land shall be submitted and uploaded.
- 3. The State Govt had proposed CA over 2 ha in DFL and KML file and DSS analysis area of CA land comes to be 0.03 ha in place of 2.00 ha.
 - a. The revised KML file of CA area of 2 ha area shall be uploaded.
- 4. The CA scheme is prepared as per Para 2.8(iii) of FAC Hanbook2019 however 10 years maintenance details are not submitted.
 - a. The details of operation for 10 years maintenance of CA plantation scheme shall be submitted.

Further, necessary action will be carried out after receipt of above information.
