Hence, state the reason for non submission of Compensatory Afforestation Scheme for the subject proposal.

Further, I am to state that in the Government letter first cited instructions have already been issued to you to submit the original Forest Rights Act Certificate of the District Collector concerned with his full name and authenticated office seal as prescribed in Form-I for linear projects in the Comprehensive Guidelines of Forest (Conservation) Act, 1980. However in the subject proposal you have furnished only the xerox copy of District Collector's Certificate without his full name and authenticated office seal of the District Collector. I am, therefore directed to request you to obtain and send the original certificate of the District Collector, Thanjavur with his full name and authenticated office seal as per the format prescribed in Form-I for linear projects in the Comprehensive Guidelines of Forest (Conservation) Act, 1980, to Government for further consideration of the proposal.
