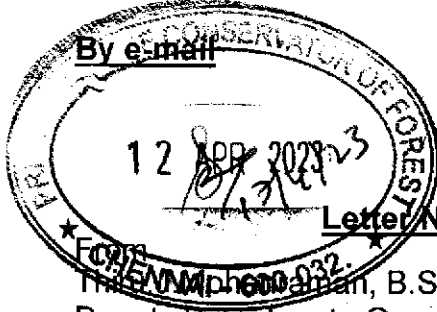

I am directed to invite your attention to the reference cited, wherein you have sent the proposal, in the Part-II of Form-A, the District Forest Officer has reported that the proposed diversion of 0.03132 ha. of forest area Compensatory Afforestation scheme has been proposed for planting of 100 number of saplings in Thagarai RF at a total cost is Rs.5,70,302/-. However in Part II, total financial outlay for Compensatory Afforestation is 5703023.7. In the proposal Work schedule in the Model estimate for Raising Compensatory Afforestation of 100 plants in degraded forest area during 2022-2023 under State CAMPA scheme estimate cost is Rs.6,86,033/- and the above cost uploaded in Parivesh portal, in Part II of Work schedule in the Model estimate for Raising Compensatory Afforestation of 100 plants in degraded forest area during 2022-2023 under State CAMPA scheme estimate cost is Rs.5,70,302/-. I am, therefore to request you to clarify the exact proposed estimate cost for the subject proposal.

2. Further, I am directed to state that, you have sent the Xerox copy of District Collector's Certificate in respect of Forest Rights Act, 2006 without Full Name and authenticated office seal of the District Collector. I am, therefore directed to request you to obtain and send the original certificate of the District Collector, Kallakurichi District with his full name and authenticated office seal as per the format prescribed in Form-I for linear projects in the Comprehensive Guidelines of Forest (Conservation) Act, 1980, to Government, as already instructed vide Government letter No.17883/FR.10/2022-1, dated 01.11.2022, for further consideration of the proposal.
