Sir,

This refers to letter No. FED/FLP/e-file/6/2023/0172/F dated 14.03.2023 of the State Govt. of Gujarat on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under section-2 of Forest (Conservation) Act, 1980. After examination of the proposal following are observed:

- 1. Justification for locating the project on forest land is not submitted.
- 2. KML file showing the area (agriculture land) owned by the User Agency and forest boundary shall be submitted along with area calculation.
- Proposed diversion area is 0.875 meter away from the Balaram Ambaji Wildlife Sanctuary. Comments of State Government is not received regarding ESZ of the Sanctuary and CWLW approval.
- 4. When did the User Agency get the ownership of the said agricultural land? In the absence of a road, how has the User Agency done his agricultural work
