Sir,

On the subject cited above, it is to inform you that after joint inspection of the above said road with your field functionaries on 17·03·2022, the Range Officer Keller Range has submitted the factual report vide his letter No. RO/507/K dated 23·03·2022, that it has been found during the course of spot inspection the following facts have been verified on grounds:

- 1. That at the very starting point of the proposed road alignment there is a CAMPA closure has been established in two parts in compartment No. 60/K during 2019-20, the total area of closure is 10 ha and total RFT is 3000.
- 2. That due to the construction of proposed road one part of said CAMPA closure having total area 5.50 ha and 1650 RFT will get almost completely destroyed due to the excavation work and other activities like dumping of excavated earth etc. as the dumping site has been proposed by the user agency in centre of two parts of said CAMPA closure.

The detail of damage due to the construction of above said road shall occur is as under:
