**Diversion of 0.6995 hectare of forest land in favour of M/s Dani Maha Mai Hydro Project for the construction of Barod SHEP (1.00 MW) within the jurisdiction of Kullu Forest Division, Distt. Kullu, Himachal Pradesh.**

Please refer to your office Memo. 92 dated 05.04.2022 on the subject cited above.

2 The proposal received vide your above referred communication is found incomplete. The following shortcomings have been noticed in the proposal which is to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index as per complete checklist.

1. Purpose wise breakup has not been given against column No. 2 of the part-I of the proposal folder.
2. Against column No. 1 (iv) of the proposal folder at Page No. 10 & justification for locating the project in forest area as placed in the proposal folder at P.No. 28, it has been stated that alternative alignments have been explored, but the details of the area and trees involved in the alternative alignments and reasons for their rejection has not been given with the certificate for minimum use of forest land as placed in the proposal folder at P.No. 29-31.
3. Against column No. 1 (ix) of Part-II of the proposal folder, the approximate distance of the proposed site from boundary of forests should also be mentioned.
4. Against column No. 13 (i), total layout of CA has been mentioned as Rs. 2.4890/-, whereas it has been mentioned as Rs. 2,61,300/- against column No. 4 of Part-II of the proposal folder. As the CA scheme is for Rs. 2,61,300/-, therefore, the financial layout of CA should be mentioned against both of these columns as per amount of CA as given in CA scheme.
5. Total forest area diverted since 1980 with number of cases has been shown as 469.4230 hectare against column No. 12 (iii) of the Part-II of the proposal folder but against column No. 14 of online Part-II, it has been shown as 3761 hectare.
6. Total CA stipulated in the district /division since 1980 onwards is shown as 1048.9881 hectare against column No. 12 (iv) (a), (v) (b) whereas against column No. 14 of online Part-II, it has been mentioned as 1019.7888 hectare.
7. Complete CA scheme as placed in the proposal folder at P.No. 48-56 has not been uploaded in online Part-II against column No. 13(ii). Further, a scheme has been prepared for Rs. 2,61,300/- on current rate wages but in the abstract of CA scheme as placed in the proposal folder, the total amount of CA has been given as Rs. 2,48,900/-.
8. Against column No. 13 (i), the area proposed for CA has been shown as 0.6995 hectare whereas CA has been proposed over 1.3990 hectare in Compartment No. Survey No. Fozal/MG-II.
9. Compartment number, name of forest may kindly be reviewed in online Part-II against column No. 13(i) as the same is not matching the compartment number and name of forest as mentioned in location map and CA scheme placed in the proposal folder.
10. Name of each document as uploaded in additional information detail in online Part-II from Sr. No. 2 to 8 has not been given against remarks column.

11. Against column 15 of online Part-II, instead of recommendation of DFO concerned, site inspection report is found uploaded. Part-II of the proposal folder wherein this proposal has been recommended by DFO concerned is required to be uploaded against this column please.
12. Toposheet and digital map of the project site as uploaded in online Part-I is not counter signed by DFO concerned.
13. Justification for location of the project in forest land as uploaded against column No. 13 (i) is not counter signed by DFO concerned. Justification as placed in the proposal folder at P.No. 28 should be uploaded against this column.
14. Copy of map indicating the location of alternative as examined is not a clear and content therein are not visible to read. Clear copy of map showing alternative alignments should be uploaded against this column.
15. Working plan prescription for the forest land proposed for diversion as given in online Part-II against column No. 5 seems not to be correct. It may please be reviewed and the name of working plan circle in which the forest land proposed for diversion is fall may be given against this column.
16. The total land proposed for muck dumping is 0.11 hectare as per detail given at P.No. 62 of the proposal folder wherein switchyard component has not been shown with dumping site No. 1. But as per component wise breakup at Part-I, the land proposed for switchyard has also been included in the land proposed for muck dumping site No. 1. Therefore, total land including the land proposed for switchyard comes to 0.11 hectare. Necessary clarification in this regard, may be given.
17. There is variation in the length of the transmission line in Page No. 75 & Page No. 76. At Page No. 75, total length of road cum T.L. has been shown as 21.20 meter but at Page No. 76, total length of transmission line has been shown as 252.09 meter. Further, RoW/Width of corridor of Transmission line has been taken as 15 meter. In this regard, it is informed that Right of Way for the transmission line should be approved in accordance with the guidelines applicable to the voltage level of transmission line.
18. A certificate issued by DFO Wildlife Division Kullu has been issued but the distanced of project site from Manali Wildlife Sanctuary and its ESZ has not been given in the said certificate.
19. Against column No. 32 of the checklist at P.No. 5, page number of document where these are placed in the proposal folder has not been given against this column.
20. It may also be ensured that each and every document have been placed in the proposal folder in original or attested from competent authority.
