Sir,

A proposal for the diversion of 0.9505 ha of Forest land (area closed under Section 4 & 5 of PLPA, 1900) categorized as 'Gair Mumkin Pahar' in revenue record for Khalsa Garden Marriage Centre cum Recreational Spot along Badkhal-Surajkund road at village Mewla Maharajpur under Forest Division & District Faridabad, Haryana has been received in this office under Section 2 of FCA, 1980 from Pr.CCF, Haryana vide letter dated 24.1.2018 (copy enclosed as Annexure-I). The purpose of diversion of forest land is commercial being Marriage Centre cum Recreational Spot.

On examination of the proposal, it is found that the status of forest land required is area closed under Section 4 & 5 of PLPA, 1900.
