A copy of the reference cited 8th cited is sent herewith to the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, Guntur, wherein it has been informed that upon examination of the approved mining plan submitted, it is revealed that the mining plan approved by the Department of Mines and Geology, Government of Andhra Pradesh is for an extent of 4.23 ha only as against the 4.72 ha as proposed and recommended by the State Government for diversion of forest area under FCA, 1980 and also component wise breakup mentioned in the approved mining plan differs with the component wise breakup mentioned in the subject proposal submitted under FCA, 1980. Therefore, the GoI, MoEF&CC, IRO, Vijayawada, have requested to re-examine and submit correct mining plan addressing the differences in the breakup of land for an extent of 4.72 ha through the State Forest Department for further consideration of the proposal.

2. He, is, therefore requested to obtain and furnish correct mining plan addressing the differences in the breakup of land for an extent of 4.72, to Government immediately, so as to forward the same to GoI, MoEF&CC, IRO, Vijayawada for further processing of the proposal.
