Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **8.233125** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the State Government the following information/clarification are still required to be submitted:

- (i) The complete administrative approval letter with specific mention of project to be submitted.
- (ii) Density of crop in part-II has been given as 40. To be corrected.
- (iii) Detailed muck disposal plan with both engineering and biological measures to be submitted.
- (iv) C:B ratio is not as per prescribed format of the FCA 1980 Guidelines.
- (v) Additional vacant space of 11.86 ha required to fulfill CA target plantation.
- (vi) In justification forest land proposed for diversion is shown 7.9031 ha, however the proposal the forest land to be diverted is 8.233125 ha. Clarification to be submitted.
- (vii) Undertaking to pay Addl. NPV is not given.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
