

In this office letter 3<sup>rd</sup> cited, it was requested to obtain No Objection Certificate from the Quaid-e-Millath Education Trust for the following

1. NOC for the diversion of 0.243 ha. of Forest land falls in Quaid-e-Millath Education Trust.
2. NOC for the demolition of 238 m. of compound wall which was constructed in the leased-out forest area.

In the letter 4<sup>th</sup> cited, the District Forest Officer has reported that as per agreement condition no.4, the District Forest Officer Chennai Division may resume the leased area whole or part for public purpose. As the legal status of the land is Reserved Forest NOC from the Trust is not necessary and for demolition of existing compound wall also NOC is not necessary. In this regard, it is informed that the user agency may be addressed to give an undertaking that



before demolishing the existing compound wall, a new compound wall may be constructed at the cost of user agency inside the existing wall.
