Sub: Diversion of 0.88 ha of forest land for construction of road from Kharangal to Chounrireg.

Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **0.88 ha** of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

- 2. After careful examination of the above-mentioned proposal of the Government of J&K the following information/clarification are required to be submitted:
 - (i) Undertaking to pay Addl. NPV is not given.
 - (ii) Site specific CA estimate as per Para 2.8 of FCA Guidelines 1980.
 - (iii) Component wise break up of forest land under B-2.4
 - (iv) Vegetation density has been shown 70.
 - (v) Detailed Muck Disposal Plan with engineering and biological components to be submitted
 - (vi) Administrative Approval of the project is not given.
 - (vii) Need to provide SOI Toposheet with project site demarcation on it instead of construction plan pdf.
 - (viii) Need to provide DGPS Map pdf with geo-coordinates instead of construction plan pdf.
 - DSS/Google Earth has found that the proposed KML file of project and found 01 Forest land feature and 02 Dumping site feature is 0.88 (ha.). Need to correct area mentioned under segment area under C Part 1 i.e., 0.63 (ha.) instead of 0.88 (ha.). The KML file of CA site is approx. 1.81 (ha.) out of it approx. 01 (ha.) vacant area available. Need 0.81 (ha) more to fulfill target plantation.
- 3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
