Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **12.052** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the UT of J&K the following information/clarification are required to be submitted:

- (i) Administrative approval of the project to be submitted.
- (ii) Enumeration list of 1645 trees is provided instead of 1666 trees. This needs to be corrected.
- (iii) Revised KML, DGPS and SOI map of the proposal site to be submitted.
- (iv) Additional vacant space of 10.1 ha for CA to be submitted to fulfill target plantation.
- (v) Cost benefit analysis in proper format to be submitted.
- (vi) Proper layout plan of the proposal with specifications to be submitted.
- (vii) Detailed muck disposal plan with engineering and biological measures to be submitted.
- (viii) Site specific CA estimate on the lines of Para 2.8 of FCA 1980 guideline to be submitted.
