Sub: Diversion of 3.122 ha of Forest land for construction of Road Khellani Dranga Hud to Saras, District Udhampur, UT of J&K-reg.

Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 3.122 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the UT of J&K the following information/clarification are required to be submitted:

- (i) Undertaking to pay CA, NPV and Addl. NPV is not given.
- (ii) Site specific CA estimate as per Para 2.8 of FCA Guidelines 1980
- (iii) Google Earth Image has been uploaded instead of SOI Toposheet.
- (iv) Geo referenced map of project site uploaded without coordinates.
- (v) Permanent/Regular employment is shown as 350 persons. Need to clarify.
- (vi) Detail Muck Disposal Plan not provided.
- (vii) DGPS of CA site is not given correctly.
- (viii) Calculation of Item-wise break up need to verify again.
- (ix) Layout plan in not approved by the competent authority.
- (x) DSS/Google Earth analysis the proposed project site is erroneous because the area of uploaded KML is 115 (ha.) instead of 3.122 (ha.). Need to revise and upload on the portal according to the online project detail for the further progress of project. The total area of KML for CA site is 01 (ha.) out of it approx. 0.40 (ha.) vacant area available. Need to revise proposed CA site because it is crossing the proposed project site and need more area to fulfill the target plantation.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.


