Sir,

Kindly refer to the online proposal of the Government of Himachal Pradesh on the above-mentioned subject, seeking prior approval of the Central Government for the diversion of **0.1666 ha** of forest land for non-forestry purposes in accordance with Section 2 of the Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980.

Since the extant proposal is a non-site specific project, as per **Para 1.10** of Consolidated Guidelines and Clarifications on Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023, MoEF&CC **"Utilization of forest area for establishing industries, construction of residential colonies, institutes, rehabilitation of displaced persons, etc. are non-site-specific activities and cannot be considered on forest land as a rule. For that matter, no non-site specific proposal can be entertained for considering approval under the Van (Sanrakshan Evam Samvardhan) Adhinyam, 1980"**. Therefore, State Govt. shall explore the Non Forest land for the proposed Diversion area
