Online Proposal No: FP/UP/Road/24596/2017

8B/UP/09/06/13/2018/FC: Diversion of Protected Forest Land for Rehabilitation and Up-gradation of Road in 4-lane with paved shoulders configuration from Kalyanpur to Naviganj (Km 229.000 to Km 289.000) section of National Highway-91 in Mainpuri District in the State of Uttar Pradesh

The proposal was submitted vide letter no. P-19/14-2-2018-800(11)/2018 dated 6th February 2018 from Special Secretary, Department of Forest, Government of UP. The proposal along with hardcopy was returned to State Government vide letter no. 8B/UP/06/13/2018/FC/184 dated 28th February 2018 due to shortcomings and placed under EDS category. The reply of EDS is still awaited. The essential details sought are mentioned below:


- 1) Signature of person making application on behalf of the User Agency has not been authenticated. (Part I A-3 xvii)
- 2) Three proposals FP/UP/ROAD/24596/2017, FP/UP/ROAD/23288/2016 and FP/UP/ROAD/22374/2016 appears to be part of widening of National Highway 91 and total extent of diversion is more than 100 ha which requires site inspection from Regional Office, MoEF&CC as per guidelines of FCA 1980.
- 3) As per GIS DSS analysis of proposed forest land for diversion and propose compensatory afforestation, following issues need rectification:
 - a) Some portion of propose forest land diversion overlaps with existing road.
 - b) Overlay of kml files of proposed Compensatory afforestation shows presence of structures. This issue needs rectification and explanation regarding suitability of site.
- 4) Benefit Cost analysis of the proposal is not as per latest guidelines of MoEF&CC. This needs revision.
- 5) The requisite documents for FRA 2006 have not been uploaded with the proposal. It has been mentioned that the same has been applied for.
- 6) Forest Gazette notification uploaded with the proposal is without date of notification and notification no.
- 7) The land schedule showing chainage wise area calculation does not provide for balance of PF available on both side and reasons for varying width requirement.
- 8) NPV calculation of forest land proposed for diversion is based on incorrect rates.
- 9) The site inspection report of the concerned Conservator of Forest is required on prescribed format.
- 10) Enumeration list with hard copy and online enumeration list shows variance of 4 trees or poles. This issue needs rectification as per ground condition.


Decision of REC -


- Site inspection report of Conservator of Forests (CZ) was discussed in presence of officials of user agency. Following issues having implications on proposal were observed:
 1. Compliance of conditions imposed by MoEF&CC vide final approval FNo 8-16/2012-FC dated 9th May 2013 for NH 91, was not done. REC expressed its displeasure over suppression of this vital information in part I of the proposal by the user agency. Compliance of condition imposed vide above mentioned letter is to be ensured.
 2. Calculation of proposed forest land diversion (Land Schedule) shall incorporate extent of fresh diversion and re-diversions (like of retail outlet, OFC cables etc.) clearly in the proposal. Essential documents related to re-diversion shall be furnished. Extent of fresh diversion is to be finalised duly deducting re-diversion area.
 3. Overlap in enumeration of trees as per approval of 2013 and present proposal shall be removed duly accounting for the details of removed trees during intervening period.
 4. User Agency will furnish details of administrative approval of the proposal.


- The issue of non submission of reply within stipulated time has already been conveyed vide letter no. 8B/UP/06/2017/FC/932 dated 26th March 2018.
