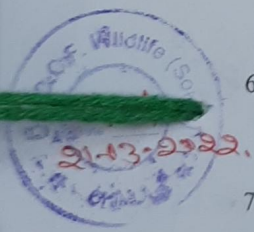

Please refer to your office memo. No. 6603 dated 26-2-2022 on the subject cited above.

2. The following shortcomings are noticed which may be attended in all respect:-
 1. The Date and place has neither been mentioned in check list nor in part-I of the hard copy, further, date in part-II is also required to be mentioned in hard copy.
 2. Page numbering has not been mentioned in part-I of the hard copy.
 3. Though the location plan as placed in proposal folder at page No. 20 is signed but no stamp has been fixed.
 4. Though the legal status on online Part-II has been mentioned Unclassed Forest but against the column No. 1 (V) of part-I of hard copy legal status of forest is mentioned UPF, necessary correction in this regard is required to be made.
 5. Against the column No. 1 (ix) 'yes' has been mentioned whereas, against the column No. 8 (v) 'whether any rear/ endangered /unique species of flora and fauna found in the area 'Yes ' has been mentioned. IF rare endangered species of flora and fauna is found in the area then detail of the same is required to be mentioned.
 6. Against the column No. 3 No' has been mentioned whereas, as per the site inspection report work of violation has been carried out. Necessary correction in this regard is required to be made.
 7. Against the column of 11 (i) (a) detail of violation, nothing has been mentioned, whereas detail of violation is required to be uploaded.
 8. The CA scheme as placed at page No. 42 and KML file of CA is prepared for 9.5 ha. whereas, CA area as mentioned against column No. 12(i) (i) of is 9.0 ha., necessary correction in this regard is required to be made.
- The NPV bill as placed in proposal folder at page No. 46 is not on current rates, revised NPV bill may be placed in folders.
- The inspection report of the committee as placed at page No. 44-49 is photocopy, original / authenticated copy is required to be placed.



11. Dumping has been proposed over 1,175 ha. forest land, hence cost estimate for plantation portion and engineering structure for reclaiming the dumping area is required to be placed in the folders.
12. The most of the documents placed at page No. 53 onward are photocopies, original/ authenticated copies are required to be placed in proposal folders.
13. The detail of length and width of the proposed road has not been found placed in proposal folders.
14. The bill of Penal CA has been found placed in proposal folders at page No. 43, whereas, the bill of Penal NPV is required to be prepared with the interest of 12% from the date of violation.
15. All uploaded and related documents in original/ authenticated copies are required to be uploaded in one PDF file against additional information detail of online Part-I.

You are, therefore, requested to make proper scrutiny of the proposal folders and submit the same after placing all requisite documents either in original or authenticated copies in it. However, the proposal folders as received with the memo are returned herewith for uploading in online portal.


