Sub: Proposal for diversion of 94.351 ha of forest land under Section.2 (iii) and 2 (ii) of FC Act, 1980 including 4.261 ha of forest land earmarked for Safety Zone (3.858 ha along the ML boundary and 0.403 ha along the PWD road) within the granted LoI for ML over 131.800 ha in Laserda Pacheri Manganese & Iron Ore Block of M/s Thriveni Earth Movers Private Limited. (Proposal No.FP/OR/MIN/149499/2021, State Sl. No.OR-094/2021 dated 23.11.2021)

With reference to your above cited memo on the captioned subject, this is to inform you that, on scrutiny of the above proposal submitted by you, the following shortcomings are observed and detailed as below.

- 1. The ORSAC vetted DGPS map of the CA land identified in Village Upperbirikela under Banspal Tahasil has not been furnished in the DP.
- 2. In one-time cost norm there is no component of Compensatory Afforestation for planting 600 seedlings per ha. So, you please ask the DFO to prepare the CA scheme over identified DFL in Jyotipur RF as per DSS analysis with basis of one-time cost norm.
- 3. The copy of Form-A (Part-I) is enclosed in the DP without state sl. number and signature of authorized officer.
- 4. The DGPS map of diverted forest land (Plate No.IIB) and Geological Plan has not been signed by the authorized officer.
- 5. The authenticated land schedule of Revenue forest, Sabik forest, Non-forest Government land and Private land have not been furnished in the DP category wise and village wise.
- 6. The User Agency has proposed to use 25.722 ha of forest land for waste dump and for other infrastructures. The UA may be asked to use non-forest land for the above purpose instead of forest land.
- 7. The purpose of applying u/s-2 (iii), 2 (ii) of FC Act, 1980 (Ammended) may be clarified.

In view of the above, proposal is returned herewith for necessary compliance on the shortcomings as pointed out above and resubmission at the earliest.
