Madam/Sir,

I am directed to refer to the Government of Maharashtra letter no. FLD-2022/C.R.272/F-10 dated 09.03.2023 on the above cited subject. In this regard following shortcomings have been observed in the information submitted by the State Govt.:

- i. The State Govt. instead of making an assessment of financial benefits that would be generated from the proposed Greenfield Airport has made the same submission as it was already placed before the FAC. Therefore, the State Govt. needs to examine the financial viability of the project and submit a detailed analysis/report as per the decision of the FAC.
- ii. The State Govt. has not given the detail of any new site on the Non-forest land which has been explored keeping in view the non-site specific nature of the project. Further presentation from the DGCA and MADC will also be required to be made before the FAC once the complete information is submitted by the State Govt and the proposal is listed in the agenda items to be considered by the FAC.

Accordingly, it is requested to furnish the above mentioned information to this Ministry as per the decision of FAC for further consideration of the proposal.
