महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि इस कार्यालय के पत्र दिनांक 20.07.2023 का जवाब राज्य सरकार के संदर्भित पत्र द्वारा प्रस्तुत किया गया है जिसमे कुछ त्रुटियाँ पाई गई है। अतः आपसे अनुरोध है कि निम्नाँकित बिन्दुओं पर अभिलेख/दस्तावेज इस कार्यालय में प्रेषित करने का कष्ट करें:-

- 1. As per DSS analysis, KML area of proposed diversion becomes only 0.03 ha instead of 2.62 ha. State Government is requested to give clarification in this regard and provide correct KML file.
- 2. CA is proposed over degraded forest land (RF area). As per Van (Sanrakshan evam Samvardhan) Rules, 2023 CA required to be selected in non-forest land only.
- 3. During examination of the proposed area KML file, it is observed that there is some construction work that has been started without approval near the river side.
- 4. It is noticed that Site Inspection Report of DFO does not contains proposal details. SIR of DFO is required to be submitted in proper format.
- 5. NPV calculation on the revised rate is required to be provided.
