- Details of permanent employment need to be uploaded correctly.
- Site specific CA estimate to be submitted.
- DSS/goggle earth shows that CA site is 3.47 ha out of it 3.20 ha vacant space is available. Need more vacant area i.e. 0.40 ha.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
