
Madam,

With reference to the subject and reference cited above, I am directed to request to submit the following additional documents / clarification etc for further consideration of the proposal under FCA, 1980.

1. In pursuance to para no 12.4 of Forest (Conservation)Act, 1980 and Forest Conservation Rules, 2003 (Guidelines & clarifications), the proposals involving diversion of Forest land located within one or more PA's require prior recommendation of Standing Committee of NBWL. As the instant proposal falls falling in Buffer area of Kawal Tiger Reserve, it is to request to obtain and submit the recommendation of SC-NBWL.
2. FDO, Asifabad has reported 6 trees to be felled in the forest area proposed for diversion. However, as per the kml file, it appears that, more trees need to be felled as against 06 numbers as reported. Hence, clarification in this regard may be submitted.

3. The detailed list of 21 proposals with apportioned extent of each such proposals and map and DGPS co-ordinates of the entire 81.4313 ha non forest area identified for CA purpose and map along with DGPS co-ordinate of the entire 71.00 ha of DFL land identified for CA purpose may also be submitted.


