**विषय: Diversion of 12.04 ha of forest land for the construction of Bhanupali-Bilaspur-Beri (BG) Rail-Line (Phase-IV) in favour of Rail Vikas Nigam Ltd. within the jurisdiction of Bilaspur Forest Division, Distt. Bilaspur, HP. (Online Proposal No. FP/HP/Rail/146861/2021).**

संदर्भ: नोडल अधिकारी-सह-अतिरिक्त प्रधान मुख्य अरण्यपाल (एफ.सी.ए.), हि0प्र0 के पत्रांक 48-5495 / (एफ.सी.ए.) दिनांक 08.03.2022.

महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

- ✓ 1. As per the document provided by Nodal Officer (FCA), the distance of proposed site from Shree Naina Devi Ji Conservation Reserve is 23 km. However, as per DSS analysis, Diversion Area touches the Protected Area- Gobindsagar WLS and major river-Satluj and Ali Khad. Therefore, exact aerial distance from boundary of Gobindsagar WLS and its notified ESZ along with comments of CWLW may be provided to this Office.
2. As per DSS analysis, Diversion Area touches the Hydrological Layer (Satluj River and Ali Khad). Therefore, comments in this regard be provided to this office.
3. The proposed DA is mentioned in proposal as 12.04 ha, however as per DSS analysis, the area is 57.35 ha. Therefore, same may be reviewed and KML file with correct area be provided/uploaded.
4. In Part – I, Para – B.1, the detail of only one proposal has been mentioned. However, detail of all the proposals submitted in the past (Phase I and Phase III) are required to be mentioned.
5. All the components, beneficiary villages, are required to be marked on KML file in distinct colours.
- ✓ 6. Since NPV rates has been revised from 06.01.2022, therefore, CB analysis is required to revise as per revised NPV. Also CB analysis is required to be submitted in ratio form.
7. Muck Management Plan needs to be authenticated by DFO concerned and barest minimum forest land certificate required to be submitted/uploaded.
8. The FRA Certificate along with all prescribed annexures including records of all consultations & meeting with Gram Sabha(s) & FRC(s) of all the concerned villages may be submitted.
9. The approach road component is mentioned in Part – I, B.2.4. It is not clear that this approach component is required for which area. Therefore, area/location for which approach road is required, needs to be mentioned in Part – I, B.2.4. Also, dimension (length & width) of approach road is required to be submitted.
- ✓ 10. In CA area (Patch 2- DPF Guru Ka Lahore), 09 ha area fall in MDF category. Therefore, same may be reviewed and revised be sumitted/uploaded.
- ✓ 11. CA is proposed only for above ground components (6.91 ha). The same is required to be proposed for

12. In few locations, proposed line is crossing the existing National Highway. Therefore, necessary NOC from the NHAI may be submitted/uploaded and reviewed in view of FCA Guidelines Para 5.6.
13. CA is proposed in UPF Ghatwal and DPF Guru ka Lahore. The detail of notification of CA as UPF/DPF area is required to be submitted.
14. The clarification regarding enumeration of trees that whether number of trees being affected are including the trees standing over surface of tunnel/underground or not. If yes, then separate list of trees standing over the surface of tunnel/underground area be provided to this office.
15. Since large number of trees (1021 Trees and 1122 Saplings) are proposed to be felled in this proposal, therefore, State Government may find out the possibility to minimize the number of trees to be affected especially ecologically important species.
16. Undertaking to the effect that no muck dumping area will be proposed in future for dumping in forest land for this proposal duly authenticated by DFO concerned is required to be submitted.
17. The State Govt. may provide the comments regarding vulnerability of the adjoining land/forest areas to the accelerated erosion after excavation of the area and mitigation measures for the same. Additionally, comments may also be provided for overall strategies to be adopted for ecological restoration of the adjoining forest/land areas along the proposed alignment.


