- ii. Part of the proposed forest land is overlapping with the Nanti Power House. The said power house has been constructed after 14/06/2014 as per the Google imagery. Clarification whether the Nanti Power House is connected with the present project may kindly be submitted.
- iii. Further, copy of approval obtained, if any, for the said project may be submitted along with compliance report.
- iv. Complete component wise/ purpose wise KML has not be uploaded/ submitted along with the proposal. The same may kindly be submitted for the purpose of DSS analysis.

In view of the above, the Government of Himachal Pradesh is requested to furnish the above mentioned information to this Ministry for further consideration of the proposal.
