13. Village wise break up of forest land proposed for diversion.
14. Details of approvals obtained/ sought for under the Act in respect of the project.
15. Detailed information in the prescribed proforma under para- A.2.XIII & B.1.I of Part-I of Form- A.
16. Details of land identified for CA with DGPS coordinates of the identified site.
17. Revised proposed forest land use plan in compliance with para- 4.5 of FC Act Guideline.
18. Check list in the prescribed format along with specific information.


