Subject: Diversion of 0.42 ha of forest land for providing basic amenities to the pilgrimage who visit the Arulmigu Malaiyandi Sastha Ayyanarkoil in Thoothukkudi District- Reg.

Sir,

Please refer to the subject and reference and to inform that, this office carried out the site inspection of the project site on 01.03.2022. Upon scrutiny of the proposal and observation made during the site inspection, I am directed to request to submit the following additional information / clarification/ documents etc for further consideration of the proposal;

- The Right of Way to access road to the temple is mentioned as 818 meters in the RF notification whereas actual distance in the field is around 1200 meters. It was informed by the field officials that the alignment of road was changed in due course, due to slope of area and for the requirement of movement of vehicles during monsoon period. Hence requirement of area for using the road in addition to the RoW mentioned in the RF Notification needs clarification;
- As per the temple authorities the original temple was constructed with old rubble masonry wall around the temple. But additional concrete building block (1298 sqft as per DSS estimate) was constructed in northern boundary, and a small pump room (59 sqft as Per DSS estimate) was also constructed but its year of construction is not known to the officials. It needs to be confirmed.

- c. The temple authorities informed that due to large numbers of pilgrims being visited during festival seasons some area in the southern portion was utilized temporarily (0.15 ha as per DSS estimate). Hence it has to be clarified that whether this area is required for the User Agency in future, else the cleared area shall be restored by planting some indigenous trees.
- d. This forest tract is a dry tract receives very less rainfall and having thorny vegetation. Hence during fire season adequate protection shall be ensured.
