



Kindly refer to the online proposal of Government of Jammu & Kashmir on the abovementioned subject seeking prior approval of the Central Government for diversion of 0.9 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

- After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:
  - Undertaking to pay Addl. NPV is not given. (i)
  - Layout plan of the project with approval of competent authority. (ii)
  - UT to explain the type of forest submitted as "dictionary meaning". (iii)
  - Revised undertaking from UA to fully utilize the muck for road construction and no (iv) dumping will be carried out during construction.
- The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
