Sub: Diversion of 1.5 ha of Forest land for construction of Road from Thathri to Kathawa, District Doda, U.T. of Jammu & Kashmir.-reg.

Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 1.5 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:

- (i) Information to be filled under A-I (ii) (iii) of part-I to understand the proposal details.
- (ii) Permanent/Regular Employment is shown 25. Need to clarify.
- (iii) UA has been filled as Central Govt in A-2, to be changed.
- (iv) In CA scheme has been prepared for per hectare @700 planted in DFL. It does not fulfill the criteria given under Para 2.8 (ii) of FCA 1980 guidelines.
- (v) Density of Vegetation has been shown 60. Need to be corrected.
- (vi) Component wise break up of forest not provided under column B-2.4 of Part I.
- (vii) Detailed Muck Disposal Plan with biological and engineering measures need to be submitted.
- (viii) Nodal Officer to specific name of proposal and area proposed in Part-IV
- (ix) DSS/Google Earth Analysis shows that total area of KML file of CA site is approx. 2.89 (ha.) out of it approx. 1.40 (ha.) vacant area is available. Need more vacant area i.e., 1.60 (ha.) to fulfil the target plantation.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
