Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 14.31 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:

- Detailed Muck Disposal Plan with biological and engineering measures required.
- Alternative route maps of road examined for feasibility of proposal required.
- Component wise break up of proposed forest land under B-2.4 is incomplete.
- CA has been provided for 28 ha. How many seedlings are proposed as per the approved CA estimate? DSS/Google Earth Analysis shows only 16 ha of suitable blank spaces is seen. Will the Dept be able to fulfil the target plantation at the proposed site?

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
