Sir.

With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. On scrutiny of the proposal, the following has been observed.

- a) The DFO, Balliguda has reported that violation has been committed by the user agency as per Para 1.21 (ii) of Handbook of FC Act, 1980 issued by Ministry dated 28.03.2019. However, number of towers and extent of the forest area used illegaly has not been reported. As per DSS analysis, total 66 towers in Balliguda Division have been constructed illegaly over forest land. Details joint verification involving forest and revenue officials and total extent of forest land used illegally in Balliguda Division may be submitted.
- b) Detail action taken report by Forest/Revenue authority under local forest act/revenue act against the erring Forest/Revenue officials and the user agency responsible for causing diversion of RF/DPF/Revenue forest land may be furnished.
- c) As per DSS, a metallic road is passing along the CA Patches at Brahamani RF, Hatimunda RF and Sinang RF. Plantation activity is present in some portion of CA patch at Brahmani RF. Agricultural encroachment are observed in CA patches at Thuapadar Gundi DPF and Sinang RF. The State Govt. may clarify the suitability of the CA land and encroachment free land.

It is therefore requested to furnish the above information to this office for further processing of the proposal.
