Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 1.65 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are required to be submitted:

- Lay out plan with seal and signature of competent authority is required.
- Permanent/Regular Employment is shown 30. Need to clarify.
- CA Scheme submitted with plants per hectare @700 will be planted in DFL. It does not fulfill the criteria given under Para 2.8 (ii). To be resubmitted with @1000 plants per ha.
- Density of Vegetation has been shown 60. Need to be corrected.
- Detailed Muck Disposal Plan with biological and engineering measures need to be submitted.
- Nodal Officer to specify name of proposal and area proposed in Part-IV of online.
- DSS/Google Earth Analysis shows that total area of KML file of CA site is approx. 3.49 (ha.) out of it approx. 2.70 (ha.). Need more vacant area i.e., 0.8 (ha.) to fulfil the target plantation.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
